This letter will serve as notice that, on Thursday, October 11, 2007, U.S. District Court Judge Wayne R. Andersen extended the Temporary Restraining Order ("TRO") previously sent to you on October 5, 2007, through and until October 25, 2007. Judge Andersen additionally set a court hearing for October 25, 2007 at 9:00 a.m. in Courtroom 1403 at 219 S. Dearborn St., Chicago, IL. Judge Andersen has indicated that he will entertain entry of a Preliminary Injunction against you at that time. If you intend to defend yourself in this matter, we urge you to appear at that hearing.

Please additionally note that the TRO served on you by fax on October 5, 2007, among other things, prohibits false or unsubstantiated products claims, including claims made for HoodiaLife and HGHLife. We urge you to immediately cease making such claims for the products on the ehealthylife.com Web site. If you continue to make such claims, we will seek appropriate remedies from the Court.
