**AFFIDAVIT OF JOHN W. FERRON IN SUPPORT OF MEMORANDUM IN
OPPOSITION TO DEFENDANTS MOTION TO DISMISS COMPLAINT (Doc. 5)**

Now comes John W. Ferron, being duly sworn and cautioned, states as follows:

1. I am over the age of eighteen, am of sound mind, and I have personal knowledge of the facts and matters stated herein.
2. I am the Plaintiff in the above captioned matter of litigation.
3. At all times relevant to the facts set forth in my civil Complaint, which is part of these proceedings, I have been a resident of the State of Ohio.
4. Since May 1, 2006, I have received about nine hundred (900) unsolicited commercial emails from the Defendants, which were delivered to me in a seemingly continuous and systematic manner at either my "jferron@ferronlaw.com" email address or my "jferron@columbus.rr.com" email addresses. True and correct electronic versions of

these emails are being filed with the Court contemporaneously herewith on a CD-ROM.

5. The Defendants' emails referenced above have been delivered to me through my computers and servers that have been located, maintained, and operated in the State of Ohio.
6. The emails referenced above solicited me to purchase consumer good and/or services, and included invitations for me to view the contents of a number of websites.
7. It is my contention that the above referenced emails violate certain laws which have been enacted by Ohio's General Assembly; including provisions of the Ohio Consumer Sales Practices Act, R.C. §§ 1345.01, *et seq.*, and the Ohio Electronic Mail Advertisement Act, R.C. §§ 2307.64, *et seq.*
8. On or about June 2007, I received a communication in response to a communication that I had previously sent to Defendants and/or their representative, Attorney Darren M. Green. The response I received is attached hereto as Exhibit 1. Attorney Green and Defendant David Linhardt have both indicated to me that Attorney Green is a duly authorized representative and agent of Defendants. Within Exhibit 1, Attorney Green indicated that certain of my identifying information, including my residential address, is associated with my email addresses and this information was accessible to Defendants.
9. I have reviewed the content of the Defendants' emails which were sent to me and which advertise consumer products. More than 115 of the emails directed to me

advertised products from well known national companies that are based in Ohio, including Bath & Body, Big Lots, JoAnne Fabrics, Proctor & Gamble, and Wendy's.

10. After a review of the content of the Defendants' emails which were sent to me, not fewer than 290 of those emails targeted me specifically as they made mention of a pseudonyms that I have used on occasion -- "Jaco" -- in the subject line of the commercial email message. "Jaco" is a name that I often use when I am completing an online form and also asking the online advertiser not to send me any more emails.
11. After a review of the message identification numbers in the emails that the Defendants sent to me, I was able to calculate that, for the period of time between November 25 and December 26, 2006, Defendants have sent approximately 25,000,000,000 (25 billion) emails.
12. I systematically and continuously received emails from Defendants from May 1, 2006 through April 12, 2007.
13. I have visited the website at BargainDepot.net, which Defendants claim is affiliated with them. That website is an interactive website which offers Ohio State College Football Memorabilia for sale through an online ordering system. The checkout section on the webpage permits a user to select Ohio in a drop-down address select box for a customer's state.
14. The internet domain name "ferronlaw.com" is registered with Internic as having a physical location in Columbus, Ohio. A copy of the ferronlaw.com publicly available WHOIS information is attached hereto as Exhibit 2. That registration is viewable at

www.networksolutions.com at the following website link:




