Dear Ms. Reich:

Per our discussion of October 24, 2007, this letter and the enclosed documents are in response to your letter dated October 4, 2007, and accompanying Document Request received by NHS Labs, Inc. NHS Labs has had previous dealings with a company known as eHealthylife.com, listed in the Document Request as being owned by one of the Defendants. The enclosed documents constitute our entire file relating to eHealthylife. I have outlined the responses to each of the categories of requested documents below:

A. Category A of the request seeks documents regarding contracts or agreements between NHS Labs and any of the Defendants. Many of the dealings between NHS Labs and eHealthylife were done informally by email, and these communications are enclosed. *See* Paragraph B, below. Additionally, any sales orders relating to eHealthylife are also included.

B. Category B of the request seeks documents regarding communications between NHS Labs and any of the Defendants. Enclosed are all the emails between NHS Labs and persons with eHealthylife that we can locate at this time. Unfortunately, we have been unable to locate the recent email from eHealthylife that you and I previously discussed. According to the best recollection of NHS Labs personnel, the email was received sometime in September or October of this year. The email was sent by a person at eHealthylife who was unknown to NHS Labs and asked for assistance in locating some information, again unknown to NHS Labs, in relation to shipping products to Canada. Because of the ongoing suit in this matter, NHS Labs did not respond to this email. We will continue to search through our files to try to locate this email.

C. Category C of the request seeks documents regarding payments by any of the Defendants to NHS Labs. Enclosed are notifications of wire transfers evidencing such payments by eHealthylife.

D. Category D of the request seeks invoices relating to any of the Defendants. Enclosed are all of our invoices relating to orders placed by eHealthylife.

E. Category E of the request seeks product labels relating to any of the Defendants. NHS Labs contracted with an outside vendor, Lightning Labels, to provide product labels for eHealthylife products. Our files indicate that Lightning Labels is located at 2369 S. Trenton Way, Unit C, Denver, CO 80231. The general practice is for all of the product labels to be placed on the product in a particular product order, which product is then shipped to the customer. As a result, NHS Labs generally does not keep product labels. However, we have been able to locate one roll of labels relating to "Burn," an eHealthylife product. All of the labels on the roll are identical, and a sample label is enclosed, as well as the related invoice.

We have undertaken a diligent review of our files in order to fully respond to the Document Request. The enclosed documents are the result of that effort and are all of the responsive documents we have been able to locate. If we locate any additional responsive documents, we will forward such documents to you.




